TREASURER'S REPORT – Frank Rosati

Revenues for the year were approximately \$56,000

- \$45,000 membership fees
- \$11,400 from sponsorships

Estimated full-year expenses projected to be approximately \$54,200

We opened the year with a balance of \$9,000 and anticipate ending the year at approx. \$10,800

PROPOSALS TO AMEND THE ARTICLES and BYLAWS of the CLUB

1. Restructure the Executive
Articles 6, 9, 11

Reduce the Executive to 12 voting positions: 6 voting convenors (3 each division, proxies allowed) + 6 voting Executives (President, Vice President, Registrar, Treasurer, Secretary, Tournament/Games Operations). Quorum would be 7 voting members (50% +1).

(Proposed by Murray DePape, seconded Kendall Dunford)

Amend the proposal to match the joint proposal (Murray DePape, Phil Prata) presented to the meeting:

6 voting convenors (3 each division, proxies allowed) + 6 voting Executive members (President, Vice President/Registrar, Treasurer, Secretary, Operations, Discipline Chair). Quorum would be 7 voting members (50% +1).

(Moved Kendall Dunford, seconded Jim McGrath)

Further amend the proposal to include a provision that no member of the Club can hold more than 1 voting position.

(Moved Chris Lynch, seconded David Hamon)

Further amend the proposal to stipulate a standing quorum of 5 voting members.

(Moved Ken Thompson, seconded David Hamon)

Further amend the proposal to permit the assignment of proxies by any members unable to attend a meeting.

(Moved Marty Wilson, not seconded - Lost)

After discussion, proposal was withdrawn by the original presenter (Murray DePape) – **no vote taken – proposal is Lost**

2. Change the O55 Division to O60
ByLaw 6 Team Selection and Player Draft

Change the Over 55 Division to an Over 60 Division.

(Proposed by Alex Boyd, seconded by Jim McGrath)

Amend the proposal to provide for grandfathering of existing O55 Division players and to permit individual exceptions to allow underage players to join the division upon Executive approval.

(Moved David Hamon, seconded Eric Krumins)

After discussion, proposal was withdrawn by the original presenter and sponsors of the amendment. **No vote taken – proposal is Lost**

3. Allow Replacement Players in the Playoffs
ByLaw 3 Replacement Players

Changes to a team's player roster during the playoffs / Cup tournament can be made in exceptional circumstances and with majority agreement between the Registrar and team convenors within the division, where the overriding criterion will be fair play.

(Proposed by Phil Prata, seconded Eric Krumins - Defeated)

4. Allow Convenors to Pre-Select 2 Players
ByLaw 6 Team Selection and Draft

A team convenor may pre-select up to 2 players who must be selected in accordance the draft rules.

(Proposed by Phil Prata, not seconded - Lost)

5. Add a White Card (sin bin) and prescribe timeouts for Yellow Cards
ByLaw 8 FIFA Laws of the Game

The Club makes use of a "white card" (also known as a sin bin). A player shown a white card must immediately leave the field for a period at the discretion of the referee, typically 5-10 minutes (the temporary dismissal period).

(Proposed by Phil Prata, seconded Scott Mason - Defeated)

6. Eliminate O55 Division Playoffs
ByLaw 14 Cup Tournament

Eliminate the playoffs for the O55 Division and continue regular play throughout the year.

(Proposed by Alex Boyd, seconded Jim McGrath - Defeated)

7. Shorten the Playoffs by splitting into two Round Robin pools
ByLaw 14 Cup Tournament

Randomly assign each team within a division to one of two playoff pools at the beginning of the year. The round robin phase of the playoff would only involve teams within the you pool.

(Proposed by Murray DePape, seconded Bryan Clarke - Defeated)

8. Prohibit members from holding more than 2 Executive positions
Article 6 Executive Committee

No person may hold more than 2 Executive positions. Ideally one of which should be an Convenor.

(Proposed by Chris Lynch, seconded Frank Mascitelli - Carried)

9. Limit members to holding a maximum of 2 Executive positions
Article 6 Executive Committee

Executives can only hold a maximum of 2 positions and only one of these can be a voting position.
(Proposed by Murray DePape – Withdrawn)

10. Reduce the discount for players over 65
Bylaw 2 Registration

Reduce the discount for Honorary Life Members (over 65 with 5 years continuous membership) to \$25 from \$50.

(Proposed by Marino Casciani, seconded Bryan Clarke)

Amend the proposal to retain the definition of Honorary Life Members, but eliminate the discount.

(Moved John Spackman, seconded Peter Whittle – Carried)

11. Clarify disciplinary actions for Code of Conduct violations
ByLaw 9 Conduct and Disciplinary Process

Add to Section e: A member may be suspended, expelled, or subject to any other disciplinary action that the Executive Committee deems appropriate under the circumstances after a hearing in which the member is entitled to be present.

(Proposed by Scott Mason, seconded Rob Lloyd – Carried)

12. Amend the Code of Conduct
Code of Conduct

Add “any other disciplinary action that the Executive Committee deems appropriate under the circumstances” to reflect above.

(Proposed Scott Mason – Withdrawn – refer to 2019 Executive)

13. Reduce Tie-Break criteria for Playoff Round Robin and substitute replays with a coin toss
ByLaw 14 Cup Tournament

Amend ByLaw 14(e): delete Least Goals Against, Replay, Replay of game(s) and add Coin Toss.

(Proposed Phil Prata, seconded Kendall Dunford – Carried)

ByLaw 15 Wooden Spoon Rules

Amend ByLaw 15: delete (e), (f) and (g).
