A. PROPOSED CHANGES TO THE CONSTITUTION

The BOTSC Constitution contains 16 Articles that outline the fundamental objectives, organizational principles and governance for the Club.

Articles of the Constitution can be changed only by majority vote at an Annual General Meeting.

ARTICLE 4 -- CLUB MEMBERSHIP

Meaning of "good standing"

ARTICLE 4: Club Membership

Add:

f) A member is considered in good standing if all eligibility criteria described in the articles and by laws have been met and membership has not been revoked or denied, in the current and previous season

ARTICLE 7 -- EXECUTIVE COMMITTEE

Eliminate the Match Secretary position on the Executive

Eliminate Match Secretary as an executive position

Background

This task is important to the club and is usually completed before the season starts with very little ongoing requirements and therefore does not need to be an executive position. Often the match secretary does not meet the minimum attendance requirement to be an executive member.

ARTICLE 9 – DUTIES OF THE EXECUTIVE OFFICERS

Add the Duties of the Past President

The past president is an important resource for the current president to ensure continuity and to leverage a wealth of knowledge. It is important that the past president does not usurp the current president and as such all formal communication with the executive committee should be conducted through the president and/or vice-president.

This article describes the role of all executives except the Past President. The executive can have only one president and it is important that the past president does not try to act like the president.

ARTICLE 12 – EXECUTIVE VOTING PROCEDURES

Convenor reps at Executive Meetings

Add:

- e) Each division may appoint a convenor representative to attend ECMs
- f) The representative will cast a votes for each convenor represented and all convenors so represented well be marked as present and included in the calculation of quorum
- g) Notwithstanding the above, a convenor may attend the ECM, in addition to the division representative, and in doing so the representative will not represent that convenor for that meeting

Background

Most of our convenors are focused on organizing and engaging our players to have a great time as a group on the pitch and not on the minutiae of the club.

ARTICLE 14 – ANNUAL GENERAL MEETING (AGM)

Member Proxies at AGM

Add:

- c) Proxy Voting
 - 1. A member in good standing may appoint a proxy to vote or otherwise act for the member through use of an appointment form (as provided by the secretary).
 - 2. An appointment of a proxy is effective when received by the secretary prior to the start of the meeting. An appointment is valid only for the period expressly provided on the form.
 - 3. An appointment of a proxy is revocable by the member any time prior to the start of the meeting by notifying the secretary.

Background

We need to provide a way members can vote (if they want to) even if they are unable to attend the AGM. This is the only way we can be sure that we are listening to ALL of our members and not just to those who are most vocal and/or most present at meetings. It is commonplace in for-profit

corporations and for nonprofits, ONCA requires a way members can vote if they do not attend a meeting and therefore this is good governance.

Decisions taken at an AGM affect all members and yet they have NEVER been taken by a majority of members (as attendance at AGMs is usually below 25% of total members), and so a small minority of members are deciding on the future of the club.

B. PROPOSED CHANGES TO THE BY-LAWS of the CLUB

The BOTSC By-Laws are comprised of 21 By-Laws that outline the basic operating guidelines of the Club.

Club By-Laws may be amended by majority vote of the members attending the Annual General Meeting. The Bylaws may also be amended by a two-thirds majority vote of the Executive at an Executive committee meeting. Bylaws cannot be in conflict with the Articles of the constitution.

BY-LAW 3 – REPLACEMENT PLAYERS

Substitute players – B Division

Add to Section D

- b) During the regular (non-playoff) season, any player who meets the age eligibility criteria for the B Division may be used as a substitute player. The maximum number of substitute players per team is 2 and substitutes may only be used if a team has 12 or fewer drafted players available unless agreed otherwise by the convenors for that game.
- c) The use of 1 or more substitutes should not result in an imbalance between the teams and if it does then the substitute(s) should play one half for each team.

Background

The Club has ALWAYS allowed A division players to be substitutes for the B Division provided they meet age eligibility criteria. This change clarifies this and restricts the number of substitutes that are allowed.

BY-LAW 6 – TEAM SELECTION and PLAYER DRAFT

Draft Process – B Division Only

- 1. Amend by-law 6b to remove "by the Team Convenors"
- 2. Insert new by-law 6c: The B division draft is to be conducted by a minimum of 3 equally ranked players (the Draft Committee) selected by the Registrar and subject to approval by the Executive. Assuming there are 6 teams in B division, the first task will be to remove 3 other equally ranked players from the draft. The Draft Committee will conduct the draft, not knowing which team they will play for. The last round of the draft will be to assign the 3 Draft Committee

members plus the 3 other players by random draw to the 6 teams. In the event there are more or less than 6 teams, the number of other players withdrawn from the draft at the start will be adjusted accordingly. The Registrar will solicit a Team Convenor from each of the teams, such appointment to be approved by the Executive.

3. Remaining clauses in by-law 6 to be renumbered and amendments to other articles and by-laws that mention Team Convenors to be consistent with this amendment

Background

We have always had seasons where there has been imbalance in the team draft. In the B Division the emphasis is on recreational play, it is social as much as it is competitive. This change to the drafting process may remove the (unconscious) bias that comes from individuals who conduct the draft. As the draft committee have no idea which team they will play for there is greater likelihood that teams will be balanced, which results in greater enjoyment for the club as a whole.

BY-LAW 12 – NON-CLUB TOURNAMENTS

Remove References to Conflicting Events

Remove By-Law 12 b.

b). Players shall not let other soccer games conflict with the Club's scheduled games.

Background

Many players attend events that conflict with scheduled games e.g. work, holidays, family events, other interests, etc. The Club requires players to satisfy 60% attendance (By-Law 2 and 19). To discriminate between voluntary absences is unfair (and the only penalty available is revoking membership). A player who is absent because they are attending their child's soccer game, or going to their cottage up north is no "less absent" than a player playing in a non-Club soccer game.

BY-LAW 14 – CUP TOURNAMENT

Playoff Formats

Remove this whole clause and replace with:

a) Convenors for each division will decide on the playoff format for their division, prior to the schedule being set for the season. In the event of a tied vote, the Registrar may cast a deciding vote. In the event no decision is reached, the executive will decide on the playoff format.

Background

This gives us the most flexibility and is what we essentially do each season. There is NO evidence that keeping points has caused any change in discipline issues. Excluding the playoffs both A and B divisions had NO change in the average number of red and yellow cards. There is copious evidence that playoffs cause discipline and playing time issues. We have lost members and/or members have gone on holiday due to the playoffs. The wooden spoon game has been defaulted for as long as I can remember because players do not bother to turn up for a game which means nothing.

Remove Section B and add:

a) Play all games in the regular season and do not keep standings. Subsequent to the regular season have a play off format where the club will keep standings, play approx 5 games each. The top Four teams play in a semi final, final and consolidation final (losing teams from semi finals play for third and fourth place). The bottom two teams play in the wooden spoon.
